### **23/15      Apologies for absence**

Apologies were received from Councillors Care, Eldret, Graves, Grimadell, Hussain, Ingall, Jones, Keith, Martin and Redfern

### **24/15      Declarations of Interest**

Councillors Afzal and Nawaz declared a Disclosable Pecuniary Interest in Item 9 – Minutes and Recommendations of the Licensing Committee dated 2 July 2015 (minute 30/15), as they declared themselves licensed members of the taxi trade.

Councillors J Khan, S Khan and Wright had previously declared to the Monitoring Officer non-DPI personal interests in the same item as having previously held taxi licences.

- 2) Note changes to the Labour appointments to its allocated places on the Personnel Committee from Councillor Redfern to Councillor Hezelgrave;**
- 3) Note the resolution of the Personnel Committee, on 2 July 2015, to appoint Councillor Raju as Chair.**

### **36/15      Appointment to the post of Head of Paid Service and Chief Executive**

Council received a report recommending a permanent appointment to the post of Chief Executive and Head of Paid Service, following the unanimous agreement of an Appointment Panel constituted to select a new candidate.

**Resolved to:**

- 1) Appoint Paul Robinson as the Council's Chief Executive and Head of Paid Service with effect from 23 July 2015 on the following terms:**
  - A salary of £160,000 per annum. Remuneration of the role of Chief Executive and Head of Paid Service will be reviewed using the Hay methodology in common with the remainder of the work force and any proposals be considered and implemented alongside the Pay and Reward project for the Council.**
  - The national conditions of service for local authority Chief Executives, including pay awards determined from time to time by the Local Authority Chief Executives Joint Negotiating Committee, supplemented by the provisions of the local Derby City Council Personnel Handbook where appropriate.**
- 2) Agree that the Leader of the Council should set the objectives for the Chief Executive and Head of Paid Service on an annual basis and progress against delivery of these objectives should be reviewed every six months in-line with the Council's individual performance management arrangements.**

### **37/15      Notice of Motion: Rail Electrification**

It was moved by Councillor Banwait, and seconded, that:

Council notes with dismay the Government decision to halt the electrification of the Midland Mainline by 2020.

Council notes the comments of the Secretary of State for Transport, who confirmed that the scheme has been 'paused' with no clear timetable for completion. Council is concerned that this lack of certainty undermines the thousands of jobs in the East Midlands that rely on the rail industry and that were preparing to bid for lucrative contracts relating to electrification.

Engineering consultancy Arup estimated that electrification would:

- Reap economic benefits totalling £450m, including £195m in the East Midlands alone
- Generate network cost savings of £30m per year
- Reduce journey times by approximately 10 minutes between Derby and London

There are financial and environmental costs to halting the work. It is estimated that:

- Carbon dioxide emissions are 20-30% higher on diesel trains
- Running costs are 80% more expensive on diesel engines
- Maintenance costs are 50% higher on diesel engines
- Leasing costs are 22% higher on diesel trains
- Network wear and tear is 11% higher where diesel trains are used

Council is opposed to the repeal or amendment of the Hunting Act 2004 and the legalisation of hunting with dogs including fox hunting, deer hunting, hare hunting and hare coursing.

Council recognises that hunting with dogs causes unnecessary suffering and distress to animals and is only undertaken to provide entertainment for a tiny minority of the British population.

Council accepts that there is no evidence that hunting with dogs makes any contribution to effective wildlife management.

Council notes that repealing or weakening the Hunting Act would be inconsistent with Derby City Council's Animal Welfare Charter.

Therefore, Council resolves to instruct the Leader of the Council to:
