The Mayor expressed his gratitude to several officers who had supported the appeal, and extended a particular thanks to the public for their generosity.

The Mayor advised that he had written to the French ambassador expressing Derby's sympathy following the terrorist attacks in Paris. Members, officers and the public stood to observe a minute's silence out of respect for the victims of the attacks.

Members were informed of a safeguarding campaign which had been launched jointly by the Cabinet Member for Safeguarding and Children and Young People, and the Youth Mayor.

The Leader of the Council informed members that a recent visit by a Chinese delegation had been very successful, and presented the Mayor with a gift which had been given to the city by the guests. The Deputy Leader informed Council that at the East Midlands Property Awards, Derby Arena had been awarded Construction Project of the Year. The award was presented to the Mayor.

#### 69/15 Notice of Motion: Tax Credits

It was moved by Councillor Dhindsa, and seconded, that:

Council is deeply concerned at the Government's planned cuts to tax credits.

Council is appalled by the Chancellor's decision to punish three million working families, while at the same time offering tax relief to multinational corporations and Britain's wealthiest individuals.

Council notes evidence collated by the Child Poverty Action Group on the impact of cuts to tax credits on a range of professions. For example, a nurse with two children working at least 30 hours per week would stand to lose £2,498 per year.

Council also accepts the findings of the Institute for Fiscal Studies which stated that increases in the minimum wage and higher income tax thresholds will 'nowhere near' compensate for cuts to tax credits.

Council believes that the low paid do not deserve to see their incomes slashed and calls on the Government to reverse this punitive and pernicious policy.

Under CP53 of the Council Constitution, it was moved by Councillor Dhindsa that the motion be altered by the deletion of the first paragraph and replacement with two new paragraphs:

Council notes the capitulation of the Chancellor regarding proposed cuts to Working and Child Tax Credits.

However, Council also notes documents from the Treasury suggesting that £1 billion will still be taken from working families next year and over £3.2 billion by the end of the Parliament in the form of cuts to tax credits and universal credit.

The proposal additionally included the addition of the words "in full" at the conclusion of the original motion.

As required under Rule CP53, the alteration was made with the consent of the meeting.

It was moved by Councillor Care, and seconded, that the motion by further amended by the addition of an additional paragraph as follows:

The Council agrees to write to the Prime Minister and Chancellor of the Exchequer to ask that they ensure that a full assessment is done on the financial impact on both the top and bottom 10 per cent of the population of any fiscal changes, and ensure that the bottom 10 per cent are not penalised.

The amendment was put to the vote and carried.
