- 3) The establishment of a single Licensing Committee, to take on the responsibilities of the previous General Licensing Committee and Taxi Licensing and Appeals Committee, including their sub-committees.**

14/15 Suspension of Constitutional Rule CP89(a)

The Council considered a report from the Monitoring Officer in respect of retaining existing appointments to two committees, contrary to Constitutional Rule CP89(a), in anticipation of Council considering, at its meeting on 22 July 2015, changed procedures in relation to the investigation of senior officers under the Local Authorities (Standing Orders) (England) (Amendment) Regulations 2015.
