# Response to the Recommendations made to SDCCG on Access to GP Services

### **SUMMARY**

- 1.1 The Adults and Public Health Board received a presentation from NHS England at their meeting of 23 March 2015. The report and the presentation were presented by the Head of Primary Care, NHS England and the Director of Planned Care for NHS Southern Derbyshire Clinical Commissioning Group (SDCCG). The Board made a number of recommendations as a result of discussions held at this meeting.
